

Enabling Umbrella SIG Essentials Trials in Your Existing Partner Console Instance

Manage all of your Cisco Umbrella trials
from your partner console.

Cisco partners are now able to manage Cisco Umbrella SIG Essentials and Umbrella DNS trials in their existing UPC/MSSP partner consoles. To become provisioned and add the SIG Essentials to your partner console, simply follow these steps.

Important note: Nothing changes with your existing UPC/MSSP enablement and usage. These steps are specific to enabling Umbrella SIG Essentials trials in the partner console.

How do I enable SIG Essentials trials in my partner (UPC/MSSP) instance?

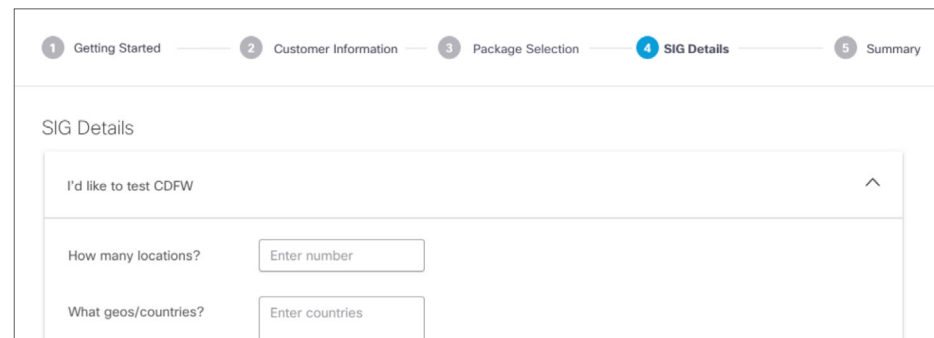
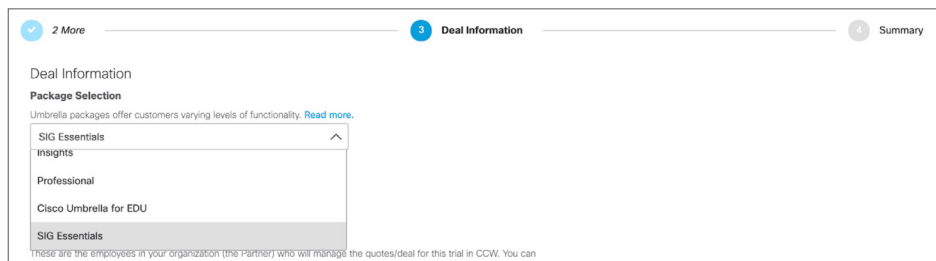
Step 3

How do I create an Umbrella SIG Essentials Trial?

Once SIG Essentials has been added to your partner console, you will be able to use the existing trial creation flow to set up SIG Essentials trials for your customers.
